1. Tax assesment and tax account statement of the last verified tax year from every person over 18-years old

In case taxing information states any of the applicant owning a real estate (apartment, summer house) a declaration of its current value is needed.

If the applicant has sold the estate, a copy of sales contract and proof of the paid debt must be presented.

- 2. Declaration on monthly income
- Latest paycheck,
 proof on paid unemployment benefits
- Proof of paid benefits, e.g social assistance
- School certificate from over 18-old students
- Verdict on paid pension
- Financial statement from entrepreneurs

- 3. Proof of pregnancy that states the expected date of birth.
- 4. If your current apartment is inhabitable or you have been evitced or your lease contract has been ended, proof must be presented, as well as possible starting job contract.
- **5.** Minors applying alone must present a written consent from their guardians.
- **6.** Immigrants must present a valid permit of residence and a copy of their passports.

The application must be renewed within 3 months by personally visiting the office, calling or via e-mail or post.

Otherwise the application will be deleted.

Applicants' credit rating will be checked.

In most cases having lost the credit rating does not prevent one from getting selected, but will have an effect on the form of the lease agreement as well as the deposit rent.
